## Profile - Aurea Vazquez-Alexander, ELEC Compliance Director



Aurea Vazquez-Alexander, Compliance Director

Aurea Vazquez-Alexander worked about half her career in government and half in the private sector.

She has been a policy counsel to the New Jersey State Senate, three governors, and several Fortune 500 companies.

Vazquez-Alexander now serves as director of ELEC's Compliance Section.

Her new job brings the daunting task of overseeing the dispersal of tens of millions of dollars in public funds to candidates for governor in a year with the largest number of contenders since 1981.

Perhaps the main challenge for Vazquez-Alexander and her staff is to disseminate the funds as quickly as possible to candidates who urgently need them while ensuring that the candidates have provided documentation legally required to receive public matching funds.

"We recognize the urgency to distribute the funds but maintaining the integrity of the Gubernatorial Public Financing Program and the confidence of the public is paramount," she said.

Under the Public Financing Program, which began in the 1970s, candidates who raise at least \$580,000 can receive up to \$5.5 million for the June 10 primary election if they agree to an overall limit to their spending.

In recently joining ELEC's staff, Vazquez-Alexander once again has returned to her native state.

Before moving at the age of three to Boston with her father Miguel, a math teacher, and her mother Rosario, a nurse, she was born in Newark at Columbus Hospital. She has always felt rooted and connected to her home state of New Jersey by visiting family every year while growing up.

"Although we're known for our grit, we'll also give you the shirt off our back and that strong sense of community is what makes me proud to be from New Jersey," she said.

Her mother, who engaged in community activism when she wasn't delivering hundreds of babies at Boston City Hospital, was a huge inspiration.

For instance, she had no hesitation to walk up to Boston Mayor Ray Flynn during a neighborhood visit to politely but firmly insist on faster garbage pickup to reduce a plague of litter endangering local children.

Vazquez-Alexander said she hopes she inherited this sense of fearlessness from her mother along with her optimism and kindness.

Tragically, Rosario Vasquez died at 52 due to non-Hodgkin lymphoma.

Vazquez-Alexander and her older siblings suddenly had to assume more responsibility for raising their large family, which includes seven natural born and eight adopted siblings. She said the experience taught her more about leadership, service to others and determination than any classroom or textbook could.

She moved back to New Jersey in 1998. While working for Legal Services of New Jersey in Camden, she often appeared before Judge Lee Laskin, a former Republican state senator. He saw that she had a strong interest in public policy and suggested she seek a job with the Legislature.

She eventually was hired by Senate Democrats and specialized in health care law as Committee Advisor to Senator Joseph Vitale, long-time chairman of the Health, Human Services and Seniors Citizens Committee. She said she enjoyed working with members of both parties, including Republican Senator John Matheussen, who preceded Vitale as chairman.

“It was the best job I ever had hands down,” she said. “The lessons I learned in bipartisan cooperation and leadership served as a framework for finding common ground through my career.”

Vazquez-Alexander went on to become policy counsel within the New Jersey Governor’s office. She advised Governors James McGreevey, Richard Codey and Jon Corzine on health and human services policy.

“I am very familiar with the inner workings of government. I know the kind of impact I’ve had in the behind-the-scenes roles,” she said.

“I appreciate the detail that goes into getting stuff done. And I enjoy doing that,” she said.

After leaving state government, she undertook a series of compliance roles with various corporations and a hospital, including Pfizer, GlaxoSmithKline, Shire, Takeda and Beth Israel Deaconess Hospital in Boston.

As Director of Compliance, Vazquez-Alexander oversees the section of ELEC that has the most interaction with candidates, treasurers and the public. Even though she knows the agency provides very good public service, she will be striving to make it even better.

“Our Compliance Section has a record of providing great customer services. I want to continue to build on our strong reputation as a resource for the regulated community,” she said.

“Education- that’s the crux of what I do. In an evolving campaign finance landscape, Compliance plays a key role in synthesizing complex information and educating the public, I’m excited to lead the Compliance Section into the next chapter of ELEC’s story,” she said.

## Primary Debate Sponsorship Applications Due by March 17

Potential sponsors of the upcoming gubernatorial primary debates must submit their applications by March 17, 2025, according to Amanda Haines, ELEC’s Executive Director.

“The deadline is quickly approaching so we wanted to send out this reminder,” she said.

Potential sponsors must submit to ELEC a completed copy of “Application to Sponsor Gubernatorial Election Debate(s)” (Form DS). It is available at:

The form is used to obtain information such as whether the sponsor has overseen previous debates, will rebroadcast debates, will withhold any candidate endorsements until all debates it will sponsor have been completed, will broadcast the debate in a foreign language, and will use a facility that accommodates persons with physical disabilities.

Forms must be submitted no later than March 17, 2025.

Gubernatorial candidates participating in the public financing program are required to participate in two candidate debates for each election and must complete the Candidate Certification for Public Financing and Debate Participation. (Form G-1A).

Candidates who are not participating in the public financing program also can participate in these debates. They must submit to the Commission reports showing they have raised and spent the applicable threshold amount (\$580,000 in 2025) along with Form G-1A no later than March 24, 2025.

ELEC’s role in gubernatorial debates is limited to picking sponsors, ensuring they meet the requirements of the law, and resolving any differences that may arise between the sponsors.

By statute, the earliest a primary debate can be held this year is April 3, 2025. The latest date is May 30, 2025. The primary election is set for June 10, 2025.

## County Parties End 2024 on a Fundraising High Note

County political party committees ended 2024 with their best fundraising during a federal election year and flushest combined reserves in more than a decade, according to quarterly reports filed with the New Jersey Election Law Enforcement Commission (ELEC). Through December 31, 2024, the 42 parties together reported \$13 million in fundraising, \$12.3 million in spending, and \$4.6 million in cash-on-hand.

“County parties are in their best financial shape entering a state election year since at least 2009,” said Joe Donohue, ELEC’s Deputy Director. “They have never raised more than \$10 million in a federal election year during that period.”

Campaign finance activity by county parties typically is higher during state election years.

Year-end fundraising, spending and cash totals were all higher in 2024 than even the average for state election years.

Fundraising was 13 percent more, spending was 10 percent higher while the cash balance is 56 percent over the average for state election years.

Donohue said the improved finances of the party committees is more evidence of the impact of a 2023 campaign finance law.

Contribution limits for all party committees in New Jersey were raised when Governor Phil Murphy signed the law (P.L. 2023, Chapter 30) on April 3, 2023.

## County Parties End 2024 on a Fundraising High Note *(continued)*

The law doubled the maximum annual contribution to county party committees from \$37,500 to \$75,000-the first increase since 2005. In addition, the law created new “housekeeping” accounts. A donor can give \$75,000 to regular campaign accounts and \$37,500 to the new housekeeping accounts for a total of \$112,500 each year.

Those higher limits were further increased on January 1, 2025 under inflation adjustments that take effect every two years under the law for non-gubernatorial contributions. Donors now can give a general contribution of \$79,000 plus \$39,500 to housekeeping accounts- a total of \$118,500 annually.

Housekeeping accounts are earmarked solely for expenses deemed administrative, including mortgages, rent, taxes, compliance costs, legal bills and collective bargaining outlays. Only the two state parties and the 42 county parties can create such accounts.
