PUBLIC SESSION MINUTES

September 14, 1981

The Chairman called the meeting to order and announced that pursuant to the Open Public Meetings Law, P. L. 1975, c.231, annual notice of the meetings of the Commission, as amended, has been filed with the Secretary of State's office, and that copies have been filed in the State House Annex, and mailed to the Newark Star Ledger, the Philadelphia Bulletin and the entire State House press corps.

The meeting convened at 10:15 a.m.

1. Approval of Minutes of Public Session of Commission Meeting of September 8, 1981

On a motion by Commissioner Axtell, seconded by Commissioner DeCotiis and a vote of 4-0, the Commission approved the minutes of the public session of the above-cited meeting.

2. Certification of Public Matching Funds

The Assistant Executive Director reported that James J. Florio for Governor, Inc. had made a third submission of \$93,480.00 on September 14, 1981, and he recommended that the Commission certify that amount in public matching funds, representing one-half of the amount for which the Florio Campaign is eligible.

On a motion by Commissioner DeCotiis, seconded by Commissioner Margetts and a vote of 4-0, the Commission certified \$93,480.00 in public matching funds for the General Election gubernatorial candidate James J. Florio (D).

3. Report on Status of Collection of Outstanding Fines

In response to a request from Commissioner DeCotiis, General Counsel Farrell submitted a preliminary report on the collection of fines for 1979 and 1980. For 1979, there is a total of 57 cases. Payment has been received in 40 cases and partial payment has been received in one case. There are 10 cases where we have been unable to obtain service and the files have been closed. There are another six cases which have been served by the Sheriff and the cases are pending. For 1980, there is a total of 29 cases. General Counsel Farrell said he would have

a complete report for the Commissin at its next meeting.

4. Report by Juana M. Schultz, Director of Compliance & Review

Ms. Schultz supervises a staff of eight, with two vacancies, plus two part time college students. She enumerated the responsibilities of the Division of Compliance and Review including: mass mailings; record keeping; review of campaign and annual reports; making recommendations for investigations; preparation of hearing lists; preparation of summaries of reports; preparation of comparative reports, e.g. 1977 and 1981 Primaries; preparation of special reports; and microfilming of old reports. She responded to questions about the extent of late filings and the quality of reports. She mentioned that in the past she attended seminars for county and municipal clerks and for candidates and treasurers.

Ms. Schultz reviewed the file of reports from an Assembly candidate in the 1981 Primary. She explained the identification number coding system and the various reports and internal records kept in the files.

5. Public Indication of Executive Session Actions

The Executive Director presented his recommendations on Commission executive session actions from July 6, July 22, August 3, August 17 and August 31 that should be made public. 6. Executive Session

On a motion by Commissioner Margetts, seconded by Commissioner DeCotiis and a vote of 4-0, the Commission went into executive session to discuss the executive session minutes of the Commission meeting of September 8, 1981, and to discuss investigations and enforcement actions.

7. The Executive Director's Report

The Executive Director reported that a legal intern is starting on a one day a week basis with the office today.

In response to a question by Commissioner Axtell about the status of the Commission's report on the public financing of the gubernatorial Primary, the Executive Director said that any action by the Legislature appears to be unlikely, especially in light of the fact that the Assembly will not be coming back until after the election. He also reported that Commission staff were commencing the follow-up with the candidates and treasurers who had not responded to the questionnaire, that the Assistant Executive Director was beginning to prepare a synopsis of the responses received to date, and that he also would be contacting graduate schools for interns to help us on statistical and research analysis.

The Executive Director reported that the lobbyist regulations had been filed with the Office of Administrative Law and that the mailings to lobbyists and other interested parties were going out this week.

8. Adjournment - The Commission adjourned the meeting at 1:05 p.m.
