Chairman Axtell called the telephonic meeting to order and asked Executive Director Herrmann to read the open public meeting statement.

Mr. Herrmann announced that pursuant to the "Open Public Meetings Act," P.L. 1974, c. 231, special notice of the meeting of the Commission has been filed with the Secretary of State's office and distributed to the entire State House press corps.

The meeting convened at 10:05 a.m. at the office of the Commission, 28 West State Street, Trenton, New Jersey.

1. Public Financing Certification

Executive Director Herrmann reviewed the public financing certification for the campaign of gubernatorial candidate Peter Shapiro. Mr. Herrmann said the campaign made its submission on Monday, September 23, 1985. He said the Commissioners would be voting to certify \$170,000 to the Shapiro '85 committee, or a match percentage of 85%. He said that the \$170,000 figure was derived as follows:

Chairman Axtell asked how much from the first submission did the Shapiro campaign have left to correct. Director of Public Financing Peter Nichols responded that there was approximately a \$12,000 error amount equalling \$25,000 in public matching funds. There were no serious errors. Executive Director Herrmann said that Mr. Shapiro thus far has qualified for:

On a motion by Vice Chairman Waugh, seconded by Commissioner Proctor and a vote of 4-0, the Commission voted to adjourn.
