PUBLIC SESSION MINUTES

TELEPHONE CONFERENCE

MAY 28, 1993

Chairman McNany, Commissioner Linett, Counsel Farrell, senior staff, and Director of Public Financing Nedda Gold Massar participated in the telephone conference. Commissioner Eldridge was absent.

Chairman McNany called the meeting to order and announced that pursuant to the "Open Public Meetings Act," N.J.S.A. 10:4-6 et seq., special notice of the meeting of the Commission had been filed with the Secretary of State's Office and distributed to the entire State House Press Corps.

The meeting convened by telephone at 10:00 a.m. at the Commission offices, Trenton, New Jersey.

1. Public Matching Funds

Candidate Jim Wallwork/Submission 06

Director of Public Financing Nedda Gold Massar informed the Commissioners that Candidate Jim Wallwork filed his sixth submission in two parts. She said that the first part was filed before the noon deadline established in the regulations and that the second part was filed at 12:16 p.m., 16 minutes late. Staff recommended that the Commission relax the noon deadline for the second portion and that the Commission consider the two-part submission as one submission for the purposes of certifying public matching funds.

On a motion by Chairman McNany, seconded by Commissioner Linett and passed by a vote of 2-0, the Commission relaxed the noon deadline and permitted the two-part submission to be considered as one.

Director Massar said that staff completed a review of Candidate Jim Wallwork's sixth submission and that the submission included a net amount of \$76,747.98 in contributions eligible for match at a 2:1 ratio. The submission includes resubmitted items. It was determined by staff that 12 contribution items representing \$3,805 were ineligible for match and that the ineligibility rate was 4.65 percent.

On the basis of its review, staff recommended that the Commission

certify \$153,495.96 in primary election matching funds to Candidate Jim Wallwork.

On a motion by Commissioner Linett, seconded by Chairman McNany and passed by a vote of 2-0, the Commission certified \$153,495.96 in primary matching funds to Candidate Jim Wallwork.

2. Adjournment

On a motion by Commissioner Linett, seconded by Chairman McNany and passed by a vote of 2-0, the Commission voted to adjourn at 10:07 a.m.
