## 5. 2025 Cost Index Report

The report described calculation of the New Jersey Campaign Cost Index (NJCCI), which measures inflation in the costs of campaigns during the period from 2021 to 2024, and the resulting adjustments of the limits and thresholds applicable to gubernatorial candidates and committees, and adjustments of the thresholds applicable to non-gubernatorial candidates and committees.
