ANALYSIS OF RECEIPTS AND DISBURSEMENTS THROUGH 10/31/83 BY STATE POLITICAL PARTY COMMITTEES AND STATEWIDE LEGISLATIVE CAMPAIGN COMMITTEES

Attached are Summary Reports reflecting campaign finance activity by non-candidate related committees of the Republican and Democratic parties.

TABLE I - provides a summary of activity by the Democratic State Committee and the Democratic Legislative Campaign Committee.

TABLE II - provides a summary of activity by the Republican State Committee and the Republican Legislative Campaign Committee.

The report of Republican campaign finance activity reflects significant changes since the 25 day pre-election report was filed and released to the public on October 17, 1983. Most significantly, the total expenditures for that period have been reduced from \$2,092,522.00 to \$1,642,235.00. This adjustment has been made based upon amended reports filed by the Republican State Committee and the Republican Legislative Campaign Committee. In general, these amended reports indicate that approximately \$100,000.00 which has been reported has been transferred from the state committee to the legislative campaign committee, when in fact it was merely transferred between state internal committee accounts. The result was approximately \$100,000.00 had not been provided to the Republican Legislative Campaign Committee nor expended by that Committee. In addition, the amendment indicates that the original reports incorrectly reported approximately \$250,000.00 in campaign-related expenses, when, in fact, those expenses were attributable to non-campaign activity of the State Committee.

In summary, as of October 31, 1983, the statewide campaign committee of the Republican party have reported total receipts of \$2,281,295.00 and expenditures totalling \$2,055,882.00. In comparison, the Democratice statewide committees report to al receipts of \$885,984.00 and expenditures totalling \$668,792.00.
