ELEC ENDORSES HIGHER PUBLIC FUNDING AND SPENDING THRESHOLDS DUE TO PRIMARY ELECTION SHIFT

During their regular monthly meeting on December 17, 2024, members of the New Jersey Election Law Enforcement Commission (ELEC) publicly agreed that specific limits related to the state's Gubernatorial Public Financing program should be adjusted if the primary election is moved to June 10.

In a letter to the legislative leaders, ELEC Executive Director Amanda S. Haines referenced legislative action in 2001 that increased certain Gubernatorial Public Financing limits due to a primary election date change. "If the 2025 primary election is moved to June 10, 2025, ELEC recommends increasing the public funds cap and the expenditure cap for qualified gubernatorial candidates," Haines said.

Dear Senate Leaders Scutari and Bucco and Assembly Leaders Coughlin and DiMaio:

The Election Law Enforcement Commission (ELEC) is aware that A5152, which moves the date of the 2025 primary election from June 3, 2025 to June 10, 2025, has passed in both houses and has been sent to the Governor. ELEC supports the laudable purpose for this change. However, as 2025 is a gubernatorial election year, ELEC recommends that the Legislature consider adjusting certain limits in the Gubernatorial Public Financing Program to account for the additional week of campaigning, should the primary election be moved to June 10, 2025.

There is precedent for increasing certain Gubernatorial Public Financing Program limits when the date of the primary election is changed. In 2001, the primary election was moved from June 5, 2001 to June 26, 2001. P.L. 2001, c. 73. This legislation also increased the maximum amount of public funds a qualified candidate could receive in the 2001 primary election and increased the maximum amount a qualified candidate could spend in the 2001 primary election. To support the enhanced limits, P.L. 2001, c. 73 appropriated additional funds to ELEC.

If the 2025 primary election is moved to June 10, 2025, ELEC recommends increasing the public funds cap and the expenditure cap for qualified gubernatorial candidates. As such an increase would be in excess of amounts originally provided for the Gubernatorial Public Financing Program, an additional appropriation to fund the increase and administer the program would be necessary.
